Introduction and Project Summary

Old Saybrook Historical Society Dedicated to Preserving, Protecting and Promoting the History of Old Saybrook

The Pequot War was an epic clash of cultures between European settlers and their Indian allies and the Pequot natives. While we only have the written word of the victors, we know that it was a brief and bloody conflict that set a pattern for settler and native relations for nearly 300 years.

In the summer of 1635 Lion Gardiner, an engineer with experience in constructing forts, signed a contract with English noblemen to build a fort and layout a town in the new world for "gentlemen of quality."

Saybrook Fort was a military outpost that became the site of the most prolonged fighting of the Pequot War. There were more than 20 Pequot attacks and more than 30 English settlers and soldiers and an unknown number of Natives were killed.

This first fort, built between 1636-1637 on the highest point on Saybrook Point, was destroyed by fire during the winter of 1647-1648. Its precise construction and layout have never been determined. Until now, much of what we knew about the first fort was based on the writings of Lion Gardiner or first governor John Winthrop, Jr.

However, archaeologists and historians from the Mashantucket Pequot Museum and Research Center, working over a period of more than five years, are confident that they have identified several battle sites and the fort's location in the east-central area of Saybrook Point.

This project was designed to build on this new information and consisted of developing programs and materials to increase awareness and understanding of the siege and battles of Saybrook Fort and the Pequot War.

A work plan was developed to accomplish this through a series of public meetings, the development of interpretative and educational materials for use in schools and by the public, and the preparation of an application for listing in the National Register of Historic Places.

To achieve the long-term goal of understanding and appreciating the significance of the siege and battles of Saybrook Fort and the Pequot War, the Old Saybrook Historical Society informed and eventually held three meetings with property owners and the public about the Fort and the Pequot War, associated battlefield sites and encouraged their active involvement in this process.

In addition, we researched and designed historic markers, developed a walking/biking tour, created seven large display panels that told this story, prepared an elementary and a secondary curriculum, prepared a manuscript for a publication on Saybrook Fort and the Pequot War, upgraded the Historical Society website with Fort and War information, and submitted an application for listing in the National Register of Historic Places.

We believe that project goals of increasing awareness and understanding of the siege and battles of Saybrook Fort and the Pequot War were achieved and are evident with the interest

and support provided by the community. Further, we believe the products and services developed by the project will sustain and advance these goals going forward.

This work was made possible with funding from the National Park Service, American Battlefield Protection Program in the amount of \$43,000 for which the Old Saybrook Historical Society is very grateful. The project began in August 2017 and ran until July 2019.

Requirements and Work Plan

Several tasks were proposed and became the major requirements of the project. These included:

- 1. Research and design interpretive markers for the Saybrook Point area
- 2. Research, design and print brochure showing key sites for a walking tour
- 3. Prepare curriculum materials for secondary school about the Siege and Battle of Saybrook Fort
- 4. Prepare a publication on the siege and battles of Saybrook Fort for public dissemination
- 5. Develop materials to train and educate OSHS volunteers and guides to conduct public programs about the Siege and Battle of Saybrook Fort
- 6. Prepare a nomination for listing the siege and battles of Saybrook Fort in the National Register of Historic Places
- 7. Expand the Old Saybrook Historical Society's website to incorporate information and visuals focused on the Siege and Battle of Saybrook Fort
- 8. Research and design traveling exhibit panels for use in schools and libraries
- 9. Develop a lecture and workshop series on preservation activities associated with the Siege and Battle of Saybrook Fort
- 10. Hold meetings with stakeholders
- 11. Prepare a final technical report

In addition to the above tasks, there were several specific contractual requirements. These requirements, and how they were met, include the following:

A. Training with ABPP

Project personnel attended a day-long training session at the Department of Interior, August 15, 2017.

B. Workplan

The contract called for submitting a detailed workplan to the ABPP which was done and approved on September 28, 2017. This formed the basis of project tasks, schedule and budget. Highlights included:

C. Hire needed consultants

The project workplan called for hiring two consultants, one for Educational Initiatives and one for Preservation Initiatives, and specific tasks for each were outlined. A 'request for proposals' was prepared for each and using the consultant list developed by the State Historic Preservation Office, archaeologists recommended by NPS, and other sources placed an announcement on various websites and invited individuals to submit proposals. Forms and procedures, including criteria, were developed and an interview committee established. The committee unanimously selected James Powers to serve as consultant for educational initiatives and Mashantucket Pequot Museum [Kevin McBride and David Naumec] for preservation initiatives. Contracts were signed and work plans approved.

D. Coordinate the public planning process

From October through January, 2018, made public announcements regarding grant and held meetings with property owners, town officials, educators and other stakeholders.

In February began developing goals and procedures for holding first public meeting, scheduled for April, 8, 2018. Property owners and other stakeholders specifically invited. At meeting, consultants introduced and made presentations about tasks. Questions and answers about project, purposes, procedures. Approximately 90-100 participants.

A group of 11 volunteered to explore strategies to encourage preservation of historic resources. This group met several times over the next six months, held productive discussions, contacted several other preservation organizations, developed a constitution and explored the possibilities of forming a permanent organization. Ultimately, it was decided to abandon the independent effort and support the work of the Old Saybrook Historical Society. Historical Society committee selected Preservation Award recipient for her efforts in saving Saybrook Fort Monument Park site among other accomplishments.

E. Complete the information gathering

Consultants worked independently and met frequently with the project director. Primary and secondary source materials were researched and obtained and added to the collection at the Historical Society archives. Meetings were held between the project director and the educational consultant to discuss and determine the nature of curriculum materials. Both met with the Old Saybrook Public Schools director of curriculum and the social studies faculty to share plans and exchange ideas.

Discussions were also held with consultants for preservation initiatives. The project director met with the Old Saybrook First Selectman, the Planning Director and members of the Historic District Commission to keep them informed of plans and seek input. Regular progress reports were presented to the Old Saybrook Historical Society's Board of Trustees.

F. Complete the draft technical report/nomination form/educational materials.

A second public meeting was held on October 14, 2018 at which time draft materials and a discussion of preservation efforts were presented, including a walking tour brochure and information about listings in the National Register of Historic Places. A short walking tour of nearby sites was conducted and well received.

Arrangements were made with school officials to provide an inservice program on Nov. 6, 2018 for teachers to review the educational materials developed on Saybrook Fort and the Pequot War. At that workshop teachers responded to an evaluative form and their comments were gathered and later shared with the education consultant. Based on teacher comments and further reflection, it was decided to develop both a secondary and an elementary curriculum. Revisions were made to the draft curriculum materials.

In December the Historic District Commission approved funding of \$2000 for the fabrication and installation of historic markers related to Saybrook Fort and the Pequot War. Reproductions of the markers were show to members of the Historic District Commission in June at which time they voted an additional \$2000 to complete the purchase of the remaining markers. Markers installed by local Department of Public Works in cooperation with Parks and Recreation department.

Also supportive was the Town Planner who arranged to have the Planning Commission underwrite the cost for printing 5,000 walking/biking tour brochures of Saybrook Fort and the Pequot War sites. Copies have proven popular and have been distributed to the Chamber of Commerce, Town Hall, various organizations and retail outlets.

Several meetings were held with the education consultant to discuss and edit the manuscript for a publication for the general public. As part of this effort, and to enhancement curriculum materials, a power point program developed along with a series of seven large-size display panels which would be available for use in schools and public places.

Work on listing the fort and battle sites on the National Register had been ongoing and a draft submitted to the State Historic Preservation Office. Initial responses were favorable but staff members had some questions regarding the listing of multiple, related sites. In June 2019 two representatives from SHPO visited Old Saybrook and were escorted by the consultant and project director to see the levels of integrity for the proposed nomination sites. Suggestions were made for adjusting the application for listing in the National Register which was done.

With substantial progress made on all products the decision was made to share these developments with the public and get feedback. A request for modification of the original grant was submitted and approved.

A third public meeting was organized and held on May 12, 2019 with a welcoming talk given by the First Selectman. The curriculum was presented to the state social studies consultant who spoke of the project's important and his plans to place the curriculum on the State Department of Education website. Walking/biking tour brochures were given to all attendees.

In June 2019 the Historical Society, the educational consultant and the project were honored by the Old Saybrook school system for its support of education with the school system's "Recognition Award."
